FROM THE SERVICE MANAGER

The period 2019 - 2020 can essentially be divided into two parts. 'Business as usual' until the end of 2019, then the arrival of 2020, when bushfires ushered in the year, altering lives and land in our region for all time. Combined with the ongoing impacts of years of drought, and the threat of Covid, 2020 is marked by high levels of anxiety, stress and fatigue in our community. This prolonged experience of stress has resulted, for many, in an accumulation of health and wellbeing impacts across the physical, emotional, relational and psychological domains. Those who have faced direct losses due to bushfire are further challenged by feelings of grief and trauma. Those who were already dealing with challenging life circumstances, such as alcohol and drug use, domestic violence, and family relationship problems, are at further risk of these issues escalating.

Members of the Monaro Family Support Service (MFSS) team were also heavily impacted by the challenges of 2020. Like many of those with whom we work, our team members also experienced losses, and watched drought and fires wreak devastation on their properties. Similarly, they also gave their personal time to protect homes and property, and to provide critical emotional and practical support to neighbours and friends, all whilst maintaining a professional presence and dedication to their roles at MFSS. Our team also adjusted to a very different working environment under Covid 19, swiftly adapting and developing new ways of doing things according to the needs in our community.

Advocacy and responsiveness to community need are core to the work of MFSS. The conditions of service delivery and concerns of families in 2020 have made new approaches and priorities imperative. Throughout this period, we have been heavily involved in the shaping of local bushfire recovery initiatives, reflecting feedback and needs of fire-affected members of our community. We have also provided a number of written submissions advocating for these priorities, including to the Royal Commission into National Natural Disaster Management, where we were also invited as part of a select charities panel to present to the Commissioners. Being fiercely committed to speaking up for the most effective response in relation to bushfire impacts in Snowy Monaro has resulted in MFSS receiving a number of new opportunities, which will allow us to extend our service in exciting directions over 2020-2021.

The foundations of our Service have been forged over 40 years, and remain central to our organisation's identity, culture and values. These foundations are based on trusted relationships, high quality service delivery, and the courage to always be led by our client's needs. Building on the pillars of this organisational history, remaining true to our mission and vision, and maintaining a commitment to social justice and advocacy, has enabled us to move strongly into new areas of work and to push for innovative approaches that create real and tangible solutions for our clients.

This has included the introduction of new therapeutic programs including music, mindfulness and rhythmic programs, adventure therapy approaches, and animal assisted therapy. Macduff, our therapy dog who features on our front cover, is now available for special appointments with children and families.

We have also refined existing, and developed new parenting courses and workshops, such as the popular 'The Worrying Seminar', aimed at equipping parents with easy to use strategies to manage anxiety in their children. Our social emotional wellbeing programs continue to be in high demand in schools, and our parenting education groups to be extremely well received.

In the past 12 months our continued growth has also enabled us to invest in new technology platforms and data management systems, which will help us to work in a more informed, more efficient way. Though the journey towards upgrading our systems and technology has not been painless, especially for a team whose focus is on clients, ultimately using technology to capture

information well and to gain feedback from our work with clients allows us to understand patterns and formulate more effective responses. This will not only enhance our ability to tell the story of the important work we do, but will also ensure ongoing quality assurance is at our fingertips.

I would like to acknowledge the contributions of our Board members, who offer their support, time, expertise and commitment willingly and voluntarily to the work of this vital community organisation.

And finally, I would like to express my greatest appreciation and gratitude to our team of highly skilled staff. Through all the turbulence of 2020 our staff have continued to design and deliver responsive, inclusive, and imaginative services which reflect the concerns and issues of families in our community. In order to continue to do so, we are extremely privileged to be able to draw on the strength of our connections with and support for one another as a team – which over through the challenges of this year has been crucially important indeed.

GROUP PROGRAMS

Our group programs focus on social emotional wellbeing and community education, including programs in schools, therapeutic programs, and parenting education.

At the beginning of July 2019, certificates for Drumbeat were presented to students at Cooma North Primary, The Alpine Steiner School and St Josephs Bombala. During Term 3 drum programs were conducted at Bombala High School for older students facing academic pressures, aimed at equipping them with stress management techniques. Drumming and rhythmic programs were also held at Delegate while parents attended a Parenting Course and with St Patricks Year 8 students.

During term 4 the program, "Rhythm Keepers" was developed, addressing anxiety management using strategies involving drumming, body awareness and response. This was presented to a group of Cooma North students. In October Community Drug Action Teams (CDAT) conducted a "Choices Seminar" where 120 year 9 students from Jindabyne schools attended a range of information sessions including drumming workshops provided by Monaro Family Support

2020 Term 1 drumming courses were taken to Berridale and Monaro High School. A small Youth Group was supported at MEIS. An adult hand drum program, A Call to Rhythm involving drumming, journaling and meditation was started, but all came to an end in mid March with a covid lockdown in NSW.



COVID RESPONSE

MFSS supported children, young people and families to deal with the impacts of stress and anxiety and adversity experienced as a result of Covid 19 by rapidly shifting our mode of delivery to range of platforms. This included appointments by phone, resources and tip sheets online, craft kits and newsletters, online playgroups and many videos with coping strategies and ideas.

A number of highlights included:

- Regular online appearances by Woody the Wallaby, including competitions, drumming, mindfulness exercises, games and other activities for families
- · Videos of songs and storytelling by our Parent Child Mother Goose team
- Parenting tip sheets, videos and links to other online resources
- Our Snowy Kids Playgroup (Jindabyne), delivered jointly with Monaro Early Intervention Service, produced imaginative online content each week for families including activities to do at home
- Online zoom sessions for our Little Ducklings Playgroup



Trakz Activities – delivered to 80 Aboriginal Students across the region

- Art workshops and NAIDOC exhibition event with Ngarigo/Yuin artist Cheryl Davison at Cooma Library
- Cultural awareness presentations at schools and preschools
- Youth Action statewide presentation about Trakz via zoom webinar. A comment from the Manager of Youth Action "It was very clear to me and everyone else that you put your heart and soul into your work, and it pays off. Community led initiative at its best!"
- Newsletter Distribution during Covid (with a focus on Reconciliation Week material and mindfulness colouring) to all participating students.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

a. This financial report is a special purpose financial report prepared for use by directors and members of the company. The directors have determined that the company is not a reporting entity.

The financial report has been prepared in accordance with the requirements of the following Australian Accounting Standards:

The financial report is prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

b. Property, Plant and Equipment
